Vendor further assures that if the Vendor's performance is contingent upon the acts of another party, the Vendor has the necessary commitment to complete the contract.

The successful bidder agrees to enter into contract on the form prepared by the City, a copy of which will be on file in the Business Office of the Milwaukee Public Library. In no event is bidder to submit its own standard contract terms and conditions as a response to this bid. Only the successful bidder is required to provide an original signed copy of their insurance certificate that complies with the City of Milwaukee's standard insurance requirements and those detailed in the Standard Terms and Conditions.
