President Mark Sain called the meeting of the Milwaukee Public Library Board of Trustees to order at 4:07 p.m. on September 27, 2022 with a quorum present. Trustee Coggs participated by conference phone.

REPORTS

- 7. Milwaukee County Federated Library System (MCFLS) Board Meeting. Trustee Erika Siemsen reported on the September 12, 2022 meeting. The new CountyCat mobile app allows for self-checkout and has been well-received by patrons. MCFLS vendor Innovative is migrating to cloud hosting on November 9th. Member libraries will not have access to Sierra software that day. MCFLS is adding 'Diversity' to subject headings and category searches to help broaden search results. Informational item.
- 8. MPL Staff Scholarship Committee Meeting. Library Director Joan Johnson reported on the spring and fall 2022 committee meetings. The joint MPL Staff Scholarship Committee was formed over 11 years ago and was the first committee comprised of MPL Board Trustees, MPL Foundation Board Trustees, and MPL Friends Board Trustees. The committee meets twice per year to review staff applications for the spring and fall semesters. Through the MPL Foundation, MPL was able to grant \$16,000 in scholarships to 7 employees in 2022. Recipients reported that the funds helped alleviate financial stress of pursuing their goals. Director Johnson thanked Trustee Kowalski for his committee service and noted one more MPL Board Trustee is needed for the committee. Informational item.

OLD BUSINESS

9. <u>Circle Keeping Initiative (IMLS) Grant Contract Approval</u>. Dr. Tammy Mays, Public Services Area Manager (Branch Libraries), presented a request to award the Circle Keeping Initiative contract for 2022-2023. Circle Keeping is a restorative practice tool intended to help support civic literacy and relationship building, including respectful, productive communication. Circle Keeping work will be done at all branch libraries, with specific focus on teens at Atkinson, Center Street, Martin Luther King, and Washington Park branch libraries. If approved, the consultants will begin onboard training in October 2022.

In March 2022 the MPL Board approved the original Circle Keeping Initiative contract award. That recipient resigned in July 2022. A second Request for Proposal (RFP) was issued on August 3, 2022 and 4 qualified proposals were received. A staff committee evaluated the proposals and recommends awarding the contract to Angela Harris and D'shaunta Stewart. Trustee Morgan moved to approve award of the Circle Keeping Initiative contract to Angela Harris and D'shaunta Stewart. Trustee Kowalski seconded. Motion passed.

10. <u>2023 Budget</u>. Library Director Joan Johnson presented a status report on the proposed 2023 MPL budget. The Library's portion of the City's budget is \$25.97M. This represents a reduction of 6.9 % (\$1.9M, including fringes) from the cost to continue budget. MPL has been working closely with Budget Director Nik Kovac and Budget & Management Special Assistant Mason Lavey on the budget allocation. The Library's budget hearing will be held on October 6, 2022.

In recent years, MPL has responded to reductions by applying the same service changes at every branch which resulted in severe cuts for all and fewer service hours for the community. In addition, staffing levels have decreased while community needs remain the same or even increase.

Director Johnson shared a map showing all MPL locations geographically. * MPL branch libraries are divided into 3 geographic clusters: North, Central, and South. The current, traditional service model for all MPL locations includes: circulation, account services, materials hold and pickup, programs, community room use, computer and wi-fi use, and outreach. Previous budget reductions led to staffing challenges that have made providing these services much more difficult. As a result of the 2023 budget, MPL will take a different approach to retain solvency of service. The service plan goal is to continue providing quality services to the public while remaining a place staff feel proud to work.

The 2023 service plan will include a mix of different service models in each branch cluster:

Expanded Service Model:

- Open 48 hours per week, Monday Saturday
- o (1) Librarian will be added to the current staffing level
- Will enhance programming and outreach
- Provide support to nearby branches that experience reductions

Maintained Service Model:

- Open 48 hours per week, Monday Saturday
- Maintain current service and staffing levels

Limited Service Model:

- o Open 37.5 hours per week, Monday Friday
- Staff reduced by about 50%
- No programming

- Closure

The proposed budget includes closing a branch library in the Central service cluster.

Virtual MPL

 MPL has seen an increase in virtual engagement and will continue enhancing www.mpl.org to retain the new audience and provide virtual or recorded programming.

The proposed branch cluster models are:

North Cluster –

- 1 Expanded Service Model
- 1 Maintained Service Model
- o 2 Limited Service Model

Central Cluster –

- o 1 Branch Closed
- o 1 Expanded Service Model
- 2 Maintained Service Model

- South Cluster -

- 1 Expanded Service Model
- o 1 Maintained Service Model
- 2 Limited Service Model

Central Library is unto itself, supports the entire system, is the Resource Library for MCFLS, and provides services to patrons throughout the state.

Director Johnson shared a chart showing criteria that will be used to determine the service model for each location. * Criteria include: recent capital investments, grant funding obligations and subsequent programming impacts, racial equity goals, and library usage. The service model changes will minimize the number of branches with reduced hours and will allow MPL to continue working strategically with community partners.

Discussion ensued about the proposed service model. The Board thanked MPL staff for proposing a unique and innovative solution to an extremely challenging budget. Trustee Coggs stated her intention to request restoration of funding to allow a limited service model at Martin Luther King branch library during construction. Trustees offered suggestions for exploring different staffing models, building a framework to use in the future, defining criteria for decision making, and possible scenarios for each cluster. Library Administration will continue to review service model options and will present recommendations at the October 25, 2022 meeting. Informational item.



Committee Chair Matt Kowalski called the MPL Board of Trustees Innovation and Strategy Committee meeting to order at 9:04 a.m. on October 4, 2022 with a quorum present. All Trustees and presenters participated by video conference.

- Committee Meeting Minutes Review. The Committee reviewed and approved the minutes from the July 1, 2022 meeting, listed as Attachment A of the agenda. Trustee Spiker moved to approve; Trustee Kowalski seconded. Motion passed.
- 2. <u>2023 Committee Meeting Schedule and Plan</u>. The 2023 meeting schedule was presented for approval. Trustee Siemsen moved to approve; Trustee Spiker seconded. Motion passed.
- 3. Race, Equity, and Inclusion (REI) Work Plan Update. Library Director Joan Johnson presented an update on the Race, Equity, and Inclusion (REI) Work Plan. The initial phase and work with consultants at P3 Development Group has concluded and the work plan is being implemented. Results and strategies have been identified; there are approximately 5 objectives for each result and 4-5 action steps for each objective. Lead staff members have been assigned to the action steps with a goal to achieve all objectives by the end of 2024. The MPL REI Committee has been created to help monitor metrics for success and ensure accountability. The committee is comprised of staff from multiple departments and positions. They will meet regularly and co-chairs Hermoine Bell-Henderson and Eileen Force Cahill will report out to Director Johnson. The committee received intensive training from P3 Development Group to learn leadership skills and build trust within the group. The next committee meeting is scheduled for October 10, 2022 and will focus on ground rules, mapping out the first set of goals, and how best to communicate with staff to ensure they feel confident about the process. The Innovation & Strategy Committee will continue to receive updates on the REI Work Plan progress and timeline. Informational item.
- 4. <u>Broadband Update</u>. Library Director Joan Johnson provided an update on MPL's efforts to expand broadband access for the community. Director Johnson is a member of the Milwaukee Broadband Partnership, which is facilitated through United Way's Techquity group. With tremendous support from Techquity, the City of Milwaukee applied for a grant through the

National Telecommunications and Information Administration (NTIA). The Enabling Middle Mile Broadband Infrastructure Program (Middle Mile) was created to expand and extend middle mile infrastructure, advance digital equity goals, and improve broadband coverage in underserved areas. Through this grant, the City seeks to align new and existing internet providers into a comprehensive network focused on equity, accessibility, and affordability. The goal is to connect anchor institutions, including MPL, to the City's fiber infrastructure and other carriers and data centers.

The Broadband Partnership will conduct a feasibility study to demonstrate the need for allocating federal funding to Milwaukee for broadband access. A Request for Proposal (RFP) was issued and vendor selection is under way.

Director Johnson has had several meetings with internet service providers to discuss digital equity goals, more affordability, and better adoption rates.

There is also interest in creating opportunities for community organizations, such as PCs for People, to provide fixed wireless or other services from MPL buildings.

Using funds from the American Rescue Plan Act (ARPA) Emergency Connectivity Fund (ECF), MPL was able to partner with Safe & Sound to develop a mobile hot spot van. The program went live in July 2022 and has been very successful. The van is used at outreach stops and at many events in summer. So far, the mobile hot spot has been used by about 30 patrons and this number is expected to increase as more people become familiar with and aware of the service. The connection has primarily been used for video chat, email, and social media. The program will continue into 2023 and there is a possibility it could expand to other partners if funding is available. Informational item.

5. **Next Meeting**. At the January 10, 2023 meeting the Committee will receive updates on the REI Work Plan and broadband access initiatives.

The meeting of the Milwaukee Public Library Board's Innovation & Strategy Committee was adjourned at 9:39 a.m. on October 4, 2022.

RACM has completed an appraisal of the property in preparation for a Request for Proposal (RFP) to set the sale price. The target date for issuing the RFP is 1st quarter 2023. Informational item.
- 4. Mitchell Street Alley. Library Construction Project Manager Sam McGovern-Rowen presented a brief review of the project and shared conceptual renderings. Creating an inviting pedestrian experience in the alley space has been a standing goal. A grant from the Mitchell Street Business Improvement District and Milwaukee Metropolitan Sewerage District and additional funding from the MPL Foundation provided the catalyst for moving forward with the project. Additionally, the MPL Foundation connected MPL with David J. Frank Landscaping who offered to provide free conceptual renderings from a landscape architect. The renderings are included at the end of these minutes. Potential features include bistro-style lighting above the space, planters and greenery along the alley and at each end, benches, a portable stage and tables, and public artwork. David J. Frank Landscaping has offered to donate the planters, plant material, and labor to install them. The Committee discussed the potential features and logistics for installation and programming in the space. Informational item.

The meeting of the Milwaukee Public Library Board's Building & Development Committee was adjourned at 9:32 a.m. on October 13, 2022.




"The Alley @ Mitchell Street Branch" - Conceptual Renderings



Director's Report

October 2022 Activities

Top priority for Director Johnson has been meetings related to the 2023 budget and service planning, including the Library's budget hearing before the Finance and Personnel Committee of the Common Council and individual meetings with Alderpersons leading up to the hearing. She attended and led several meetings since the hearing with the Mayor's Budget Director and the Library's analyst, the Foundation Director, Trustees and the Library's Administrative Team.

Expanding access to high speed broadband is still a top priority for the Library and in an effort to advance those goals, Director Johnson has met with local philanthropists, telecommunications service providers, the Mayor and others. Separately, Johnson continues to participate with the Milwaukee Broadband Partnership. Due to progress along both fronts, Johnson expects some movement toward developing a proposal for action to be considered by the Board in early 2023.

Fall is the season for fundraisers, galas, and annual meetings and Director Johnson was in attendance for many of these events beginning with the Library's own Ben Franklin Awards Celebration where she participated in the program. As an ally with many community partners, she attended events in support of Journey House, Milwaukee Downtown, BID #21, Westown Association, ABLE (Audio & Braille Literacy Enhancement) and HGA.

Johnson regularly engages with local community leaders including with the Directors of COA Youth and Family Centers and Marquette University Raynor Memorial Libraries. She also attended a stakeholder's informational session regarding the Iron District Development happening in very close proximity to the Central Library and an aldermanic town hall meeting.

September 2022

Summary of VIRTUAL and IN-PERSON PROGRAMS:

MPL HELPS PEOPLE READ

Coming to America Book Club. This book club grew out of a grant MPL received in 2020 from The Yiddish Book Center to do four reading groups. After the fourth title, some members expressed interest in continuing, and the Book Club was born. Because of the pandemic, the Reading Group was virtual and the Book Club began before in-person programming resumed, so this book club will remain virtual. A highly engaged core of between six and ten readers gathers every month and this past month Jeannee Sacken, the author of "Behind the Lens," joined us to talk about our September book. Attendance: 8

<u>Cactus Book Club.</u> Milwaukee Public Library was the guest host for this ongoing offsite book discussion group at Cactus Club, a music venue and community gathering place in the Bay View neighborhood. In honor of Banned Books Week, we led the group in a discussion of *Saga: Book One*, a collection of the first eight volumes of the fabled graphic novel series written by Brian K. Vaughan and illustrated by Fiona Staples. Saga has been frequently challenged for content in various public and school libraries, even making it on ALA's list of most challenged books in 2014. The group had a welcoming and insightful discussion of censorship, war, sexuality, family relationships, and colonialism in the book and our larger world. Attendance: 10

MPL HELPS PEOPLE LEARN

Computer Basics. Earlier this year, MPL was selected to be part of a cohort of 160 libraries nationally that will receive funding to provide technology workshops using DigitalLearn resources via a grant administered by the Public Library Association (PLA). Villard Square was chosen as the first location to host our series of computer classes. The Students were really excited to be back at the library learning about computers. Our 3 attendees were attentive for the entire class and asked a lot of questions throughout. Each student expressed their intentions to come back each week to learn more. The Digital Literacy Team is looking forward to the rest of the series, and are finding ways improve the classes for next year. Attendance: 3

National Voter Registration Day Mini-Carnival. Good Hope was one of four sites for our National Voter Registration Day mini-carnival. Volunteers from the League of Women Voters were at each site answering questions and helping people register to vote; there was a prize wheel and people spun, answered an age-appropriate question (there were child/teen and teen/adult question decks); the Election Commission brought voting machines and everyone was eligible to vote for their favorite Wisconsin Food and Wisconsin sports team; and everyone got a cookie. At the Good Hope site, at least three people registered to vote and one did an address change. At Central, Jacki Lyden and Delia Sava represented Writers for Democratic Action, a national grassroots coalition of writers promoting voter literacy and voter awareness. Attendance: Good Hope, 47; Central, 15 (Kelly Bolter); Washington Park, 11 (Brittany Lee); Mitchell Street, 30 (Kimberly Luedtke).

<u>Snack Hack: You Are What You Eat!</u> Snack Hack is a food and nutrition curriculum program structured as weekly sessions designed to teach all aspects of food: nutritional elements, food groups, cooking principles, history of food, how food is grown, cultural connections to what we eat, how food works in our bodies and methods on how to prepare meals at home. Sessions include a cooking demonstration and a snack for attendees. September began "Block 3" of the 4 Blocks that the Program is divided up into. The focus of Block 3 was to provide attendees *Tools for Healthy Habits*, such as completing a self-assessment, reviewing the My Plate guidelines, comparing portion sizes and teaching methods of eating in moderation. Total attendance at 4 weekly sessions: 61

<u>Super Reader Squad & Teen Summer Challenge In Libraries.</u> The Super Reader Squad and Teen Summer Challenge programs continue to support MPL's organizational value of creating a city of readers and lifelong learners. Through a variety of summer learning opportunities, youth are encouraged to read for fun, discover what they love to read, and pursue their interests by participating in either Super Reader Squad or Teen Summer Challenge. The programs have included a virtual option since 2017. The Super Reader Squad registered 3,167 children in libraries and 474 teens participated in the Teen Summer Challenge through their library. Participation: 3,641

Summer Outreach to Child Cares. Through a DIY Super Reader Squad kit, MPL staff connected with group and family licensed child care centers to share current information about MPL services, resources, virtual programs, and the Super Reader Squad. Child care centers were enrolled in the Super Reader Squad program and built a connection with a community partner during a particularly isolating time. Teachers were provided access to recorded read-alouds, book talks, guided educational activities in English and Spanish, lesson plan ideas, and information about continuing education credit opportunities. Giveaway books were delivered so that site staff could send a new book home with each child. In 2022, summer outreach to child care sites reached 95 group and family child care centers. Super Reader Squad Participation: 4,066

Summer Outreach to School Age Groups. Through a DIY Super Reader Squad kit, the Super Reader Squad program was taken to school age students in summer programs that include MPS recreation, summer school and Community Learning Centers, Boys and Girls Clubs, Children's Outing Association, choice, charter and parochial schools and other community-based organizations. The program introduces students to interesting books to motivate them to read in summer while encouraging their progress. Deposit collections of library books were delivered to 80 sites to be used throughout the summer and giveaway books were delivered to each site so that site staff could send a new book home with each student. MPL offered training to site staff to support them in implementing the program at their site and site staff received ondemand access to recorded read-alouds, book talks, and guided educational activities in English and Spanish. In 2022, summer outreach to school age sites worked with 116 partners. Super Reader Squad Participation: 10,404

<u>Public Art Scavenger Hunt.</u> This summer, the Super Reader Squad and Teen Summer Challenge featured a Public Art Scavenger Hunt again. The Scavenger Hunt encouraged teens (and patrons of all ages) to explore Milwaukee neighborhoods and enjoy the public art available. Participants accumulated points toward summer reading for every art object they visited. Each branch also featured a drop-in art activity inspired by a neighborhood art piece so that children and teens could "level up" the Scavenger Hunt. Visits to Public Art Scavenger Hunt Sites: 1,199

MPL HELPS PEOPLE CONNECT

<u>Capitol Walking Club</u> Walking Club attendees improved their fitness and developed friendships over the course of the summer. One woman who attended every session since July began walking with a cane and needed to stop for regular breaks. She has since increased her walking speed and no longer brings a cane. The final session had a new attendee who plans to attend the Gentle Chair Yoga class at Capitol in October. Attendance: 13

Music in the Courtyard: The Kitchen Boys. The Kitchen Boys a small local band consisting of Aaron Heffernan on harmonica and washboard and Bob Drucker on banjo and guitar gave patrons at The Zablocki Library a very entertaining night playing a variety of Appalachian and Bluegrass music. The patrons who attended enjoyed listening to the music and participating in singing along with songs like Ring of Fire by Johnny Cash and Take Me Home, Country Road by John Denver. We were to have the program in Zablocki's new refurbished Courtyard, but the weather did not want to cooperate, with temperatures in the fifties and the wind blowing pretty hard we moved into the community room where the acoustics made the music sound wonderful. Attendance: 14

Knot Just Knitting. This group, led by master fiber artist and community member Ruth Shank, was planned for Good Hope before the pandemic and while we were preparing for a grand opening and a full array of programs. It was our first inperson program in August of 2021, and possible because of our outdoor space. We met again in September and October before going on a weather-related hiatus. It resumed in June, when indoor programming was offered for the first time since the pandemic. Two of the previous year's patio knitters returned, and we have been growing steadily since. September's program was the largest in-person adult program yet at Good Hope. Attendance: 8

BBQ Showdown: Pitmaster Challenge. The BBQ Cook-Off was an interactive, fun, competitive BBQ-themed "grill off" between local chefs. The Cook-Off allowed for fellowship, a cooking demonstration, information on cooking methods, as well as a complimentary meal offered to the attendees. This program provided the community an inviting avenue to easily access the Library and its vast resources. By attracting the community through this program, more residents will be willing to engage in what the Library has to offer. Attendance: 40


The Super Reader Squad and Teen Summer Challenge continue to encourage children and teens to read, explore their interests, and learn during the summer with a focus on helping young people develop their own identities as readers. In 2022, children and teens were again invited to Read, Create, and Discover through our summer reading programs. Participants chose what they wanted to read, visited MPL locations to participate in art activities inspired by Milwaukee public art, and discovered public art while exploring different Milwaukee neighborhoods. Participants picked out a high interest, high quality book for their home library upon registration.

While in-house participation is still rebuilding after COVID shutdowns, outreach to child cares and school age sites throughout the city is growing. In 2022, MPL served more children and teens through outreach than at any other point in the 20 year history of summer reading outreach.



Re: Award Recommendation for Financial and Compliance Audit Services of the Milwaukee Public

Library Trust Fund.

The Milwaukee Public Library issued a Request for Proposals for Financial and Compliance Audit Services on August 5, 2022. The RFP for this professional service was last issued in 2018.

The Request for Proposal documents were sent to 28 local and regional firms with auditing and accounting experience. Staff researched and investigated possible proposers with due diligence.

Only Reilly, Penner, & Benton, our current accounting firm, submitted a proposal. Given their experience, qualifications, audit approach, and cost structure, the Business Office team at Milwaukee Public Library recommends accepting this sole proposal. The new term covers 2022 to 2024 audit years. The Milwaukee Public Library will have the option to review and terminate this contract at any time under certain conditions in City of Milwaukee contracting rules. The contract will have an option to extend for one additional two-year period by mutual consent.




MPL Technology Innovation & Timelines

The Milwaukee Public Library strives for ongoing and sustainable technological innovation to support customer experiences, efficient resource management, and optimization of staff time. These innovations have created opportunities to enhance and maintain services for patrons as the City of Milwaukee and the Milwaukee Public Library have experienced increased costs and challenging budgets. While not the original goal, some innovations have allowed MPL to sustain patron services with reduced staff. Those possibilities have been exhausted at this time. In 2010, MPL implemented RFID systems, including self-check stations, allowing MPL to sustain reductions to circulation staff. Having at least one circulation staff member available at those service points provides critical support for patron needs. MPL's Acquisitions/Serials Department, with Milwaukee County Federated Library System support, updated electronic order loads in 2019 for improved efficiency and to enhance timeliness of material processing. Unit staffing reductions in 2020 created a roughly neutral effect.


As MPL explores technological innovations, it must factor costs for overhead, maintenance, skilled staff, and IT support, requiring a balance between innovation and actual cost-savings. For example, MPL installed RFID sorters at some locations and the cost of initial investment, operation, and maintenance of these units means they are only a financially viable solution at locations with higher levels of circulation. The equipment still requires trained staff to process outliers, complete sorting, and shelve materials. Additionally, MPL has expanded digital access and remote opportunities to interact with the library and access resources during the same 20-year period of reduced staffing levels. The Milwaukee Public Library continues to explore technology that would support and enhance services to provide the high-quality customer service patrons expect and deserve in a 21st Century Library.
